First come first served, subject to the following:-

If there are 2 or more parties interested in purchasing the same specified residential property(ies) at the commencement of the Time of the Sale on any Date of the Sale, balloting will be conducted to determine the order of priority of property selection.

In case of any dispute, the Vendor reserves its absolute right to allocate any of the above specified residential property(ies) to any person interested in purchasing by any method (including balloting).

**Other matters:**

1. The sale of the specified residential properties is subject to availability. Please note that the Vendor's admittance of any person to the Sales Office or a waiting queue does not guarantee that that person will be able to purchase any specified residential property.

將提供出售的指明住宅物業售完即止。任何人士獲賣方批准進入售樓處或獲賣方接受輪候，均不保證該人士能購得任何指明住宅物業，敬希注意。

2. The Vendor does not accept any person interested in purchasing having queued up before the Time of the Sale on any Date of the Sale.

3. For the safety of the interested persons and maintenance of order at the Sales Office, the Vendor reserves its absolute right to, in the case where a Typhoon Signal No. 8 or above or Black Rainstorm Warning is in effect in Hong Kong or where the Vendor considers that there being an event affecting the public health, safety or order in the Sales Office and/or the vicinity of any of foregoing, close the Sales Office and/or postpone, extend or modify the date, time, period, deadline or place of any sale of specified residential properties to such other date, time, period, deadline or place as the Vendor may consider appropriate. Details of the arrangements will be announced on the website of the Development or by such other means as the Vendor considers appropriate and interested persons will not be separately notified of the same. The Vendor reserves the absolute right to reject any person to enter into the Sales Office and/or any designated venue. The Vendor's decision in this regard shall be final and binding on all persons.

為保障有意欲購買的人士安全及維持售樓處秩序，當八號或更高風球訊號或黑色暴雨警告在香港生效或賣方認為發生影響售樓處及/或任何上述地點之附近之公共衛生、安全或秩序之事件時，賣方保留絕對權力關閉售樓處及/或延後、延長或改動任何出售指明住宅物業之日期、時間、期間、期限或地點至賣方認為合適的其他日期、時間、期間、期限或地點，有關安排的詳情將於發展項目網站或以其他賣方認為合適之方式公布，有意欲購買的人士將不獲另行通知。賣方保留絕對權利拒絕讓任何人士進入售樓處及/或任何指定會場。賣方就這方面所作的決定為最終決定，對所有人士均具有約束力。
